Countess Ilona Edelsheim-Gyulai, born in 1918, is the daughter-in-law of Admiral Nicholas Horthy, Hungary's Regent from 1920 till 1944. After her husband, Istvan Horthy, died in a Nazi instigated plane crash on the Russian front, she became the Regent's confidante and this brought her into the centre of events in the last phase of WW2 in Budapest, before the whole family were imprisoned by the Nazis. Her popular autobiography *Honour and Duty* has been published in the UK and Hungary. She will speak about her experiences and answer questions.

Her son Istvan Horthy was born in Budapest in 1941. He studied physics at Oxford and civil engineering at Imperial College, and has worked in the UK, Indonesia and the USA as a civil engineer and business strategy consultant. His present work also draws on his lifelong interest in psychology and spirituality. Since 1995 he has been president of the Guerrand-Hermes Foundation for Peace, which is interested in exploring sustainable scenarios for the human race. He will speak about his life, his current interests, and some thoughts about Hungary in the 21st century, followed by questions and answers.
