MARYLAND DEFENSE COUNSEL CREATES LEGISLATIVE BRANCH LIAISON, NAMES GARDNER DUVALL TO POST

Baltimore, Maryland, June 13, 2006. The Maryland Defense Counsel (MDC) announced today that it has created a new office, the Legislative Branch Liaison. President Joseph Jagielski also announced that the first person appointed to the post is Gardner Duvall, MDC president in 2004-2005. "I wanted a Legislative Branch Liaison to solidify MDC's expanding presence and growing influence in the General Assembly," Jagielski said. "That achievement is the work of years, and the largest part of the credit for enhancing our visibility in the judiciary committees goes to Gardner."

"Gardner has become so recognizable to the members of the judiciary committees that we want to capitalize on that experience. He can provide continuity while mentoring the members of the standing MDC Legislative Committee, which lets us build our resources without losing experience," explained president Jagielski.

"Being named the first MDC Legislative Branch Liaison is really an honor. MDC has greatly expanded its recognition in the judicial, executive, and legislative branches since I became an officer as Legislative Chair in 2000," Duvall said. "As I worked my way through and out of the MDC officer positions, I stuck with the legislative effort, and that continuity has really paid off for MDC."

Annapolis lobbyist John Stierhoff, who works on behalf of Maryland Defense Counsel in the Generally Assembly, noted that "Gardner has helped take the MDC to a new level of recognition before the Legislature and Executive Branch. With the General Assembly facing potentially its most significant turnover in decades, Gardner will provide consistency and stability that will serve the MDC well during the coming legislative term."
