William Orbinson

Mr Orbinson is the only member of the NI Bar to have qualified as a Legal Associate of the Royal Town Planning Institute, and to be an Affiliate of the Irish Planning Institute. He is also the sole NI Associate of the Planning and Environment Bar Association: the Specialist Bar Association for Planning, the Environment and Local Government. A founding member and past Chair of EPLANI: the Environmental and Planning Law Association for NI, Mr Orbinson has served on the local branch Committee of the RTPI, as well as on various development-related committees of the Royal Society of Ulster Architects. He has taught planning at QUB and UUJ, and is a regular speaker at planning conferences and Solicitors' CPD events throughout these islands. He contributes to specialist planning, property development and architectural journals, and is the author of our main texts on planning policy, prematurity, and local government planning functions

Mr Warke is currently a Committee member of the Environmental and Planning Law Association for Northern Ireland (EPLANI) and has served on the local branch of the Royal Town Planning Institute
